Electives

The MPA program will permit joint degree students to count LAW electives from a pre-approved list of LAW courses (listed below) as MPA electives. Therefore, joint degree students will take nine required MPA courses (totaling 27 credit hours) and the four additional required MPA elective courses (totaling 16 credit hours) may be LAW electives. UDSL will permit joint degree students to count two MPA courses (totaling 6 hours) towards LAW elective requirements.

GPA Requirement for Law Students

Law students must maintain a cumulative grade point average of 2.5 or higher to enroll in graduate level courses.

Course Load Limits for Law Students

During any regular semester, every law student must enroll in courses totaling at least twelve, but not more than eighteen, credit hours. No student whose cumulative grade point average is below 2.50 after receiving grades at the end of any semester may enroll in more than sixteen (16) credit hours in the subsequent semester. Hours taken as part of the MPA program will be counted towards the maximum credit hour limit.
